## 2025 FEES FOR FULL FEE PAYING OVERSEAS STUDENTS

MLC School is registered by the NSW Education Standards Authority (NESAs) to accept overseas students (CRICOS Provider Code: 02328D). The Australian Government classifies an overseas student as someone who is neither an Australian citizen nor one who holds an Australian Residency Visa, and who attends an Australian school as a 'Full Fee Paying Overseas Student'. The School does not receive government support for such students and as such these students must pay full fees

## Payment Information

- ▲ Fee statements are sent out at the start of each term and are payable within **14 days**. We seek your support in ensuring these payment terms are met.
- ▲ A late payment fee of \$75 will apply if fees are not paid by the due date each term.
- ▲ Sibling Discount is 10% for the second child, 12.5% for the third and subsequent children.
- ▲ **A student cannot commence a new term whilst the previous term's fees remain unpaid.**
- ▲ Our preferred payment option is BPAY.
- ▲ Year 12 families are billed at the beginning of Terms 1, 2 and 3.
- ▲ **A term's notice in writing to the Principal is required for student withdrawal, otherwise a term's fee will be payable.**

# GENERAL INFORMATION

## Sibling Discount

While sisters are currently attending MLC School, a reduction of 10% of tuition fees will be made for a second child and 12.5% for every subsequent child. Students must be attending the School simultaneously for any discount to apply

## Tax-Deductible Donations

It is hoped that all families will support the ongoing development of MLC School through the contribution of tax-deductible donations to the Building Fund. These contributions are especially appreciated and essential for the future of the School.

## Parents and Friends Association

The Parents and Friends Association (P&F) plays an important role in supporting and connecting parents through social activities, running and organising events, and providing peer to peer insight. In consultation with the Principal, the P&F financially supplements resources and programs deemed to add value to the School community in general.

Subscriptions to the P&F Association are optional but highly encouraged.

## Withdrawal of Student

The withdrawal of a student requires at least one full school term's notice in writing to the Principal, otherwise, one term of the annual tuition fee in lieu of notice will be payable.

## When Fees are Charged and Due

Fee statements are sent out at the start of each term and are payable within 14 days. We seek your support in ensuring these payment terms are met. Year 12 families are billed at the beginning of Term 1, Term 2 and Term 3. Our preferred payment option is BPAY.

A late payment fee of \$75 will apply if fees are not paid by the due date each term.

A student cannot commence a new term whilst the previous term's fees remain unpaid.

## Payment Methods

MLC School offers a range of methods for the payment of school fees. Parents/carers have a choice of the following payment methods:

## Edstart

MLC School has partnered with Edstart to provide additional payment options for school fees.

Edstart is a specialist education payments provider specifically designed to manage all education-related expenses in one place. You may package any education-related expenses including tuition fees, uniforms, textbooks and extra-curricular activities, which can then be paid for up to five years after a child has completed her studies. You can choose weekly, fortnightly or monthly repayments on any date in line with your income. Business owners can also choose payment structures in line with your seasonal cash flow. This is an optional service, acceptance is subject to approval and fees which will be made clear throughout the process.
